

## ASBESTOS MANAGEMENT



# To be truly effective, health and safety has to be an everyday process supported by all as an integral part of work-place culture.

Every business, no matter how small or large, has a legal and moral responsibility to care for the health and safety of their workforce and to ensure that they go home safe at the end of the working day.

Australia has the second-highest rate of mesothelioma deaths (a rare cancer caused by asbestos exposure) in the world. This is attributed to the fact that we had the highest per capita rate of asbestos use in the world between 1950s-1970s. As a result, asbestos or ACM (Asbestos Containing Material) is now highly regulated in Australia and a person with "management or control" of a workplace must ensure asbestos at the workplace is identified, recorded in a register and subject to an asbestos management plan.

## As a person conducting a business or undertaking (PCBU) you have these key responsibilities:

- Use a competent person to conduct an Asbestos Audit to identify all asbestos/ACM
- Clearly label the location + presence of all ACM at the workplace
- Ensure an asbestos register is prepared, maintained, reviewed and kept at the workplace
- Develop an Asbestos Management Plan and review it at least every 5 years
- Control the risk of exposure for all employees
- Ensure suitable + adequate training is provided

All workplaces must have a current asbestos register readily available on request. However, other requirements vary as asbestos is regulated by the states and territories. This can make your life very difficult if you don't keep on top of all the variations and any changes/updates that occur. Did you know that directors can be personally liable for breaches of the regulations with penalties of \$600,000 and/or 5 years imprisonment? Clearly, it makes sense to use the services of an asbestos expert like JTA Safety to ensure that you receive the most up to date advice and guidance.

- One-quarter of serious claims required 12 or more weeks off work

The legal requirement for follow up audits can vary from annually to five yearly depending upon the State.
